As Participant or Guardian/ Parent of Participant I do hereby agree to completely release, waive, covenant not to sue, indemnify and hold harmless the District 1 Idaho High School Rodeo Association, the host committees, and any and all sponsoring groups, organizations, and individuals from all responsibility and liability for any and all injuries or disablements, or illness of any kind or nature whatever, suffered or inflicted to person or livestock, or damage to or theft of equipment through participation in the 1st District Idaho High School and Jr. High Rodeos. I agree and understand that all the risks related to the above-named hazards and any other are expressly assumed.

I give the nearest hospital permission to administer necessary emergency treatment for injuries he or she may incur while participating in the 1st District Idaho High School and Jr. High Rodeos. I understand that each contestant must be and is covered by medical insurance. I hereby release rodeo sponsors, and stock contractors from all liability. I further do hereby release the 1st District IHSRA, its officials, directors, and volunteers, from all liability for injuries he/she, and/or property may sustain.

I understand that (1) failure of a contestant or his or her parents to follow the chain-of-command or (2) violation of any NHSRA rule or ground rule shall result in probation or immediate disqualification of the contestant.

Participant or Guardian/Parent of Participant shall pay any attorney fees or costs incurred by 1st District IHSRA in enforcing this Agreement.

If any portion of this Agreement is held to be invalid by a court of law, then it is agreed and intended that all the remainder shall, notwithstanding, continue in full force and effect.
